

How to Comment on the Outline Planning Application for the Proposed Tasley Garden Village Development

Outline Planning Application

Morville Parish Council has been informed by Shropshire Council that the following Outline Planning Application has been received from Bloor Homes and Taylor Wimpey:

PLANNING REFERENCE: 25/01722/OUT

DEVELOPMENT PROPOSED: Outline application, with all matters reserved except for principal means of access, for development comprising up to 1,500 residential dwellings (Use Class C3) including specialist housing for older people (Use Class C2 or C3), up to 14.6ha of employment land of Use Class E, B2 and B8a uses, a mixed-use local centre of up to 1,500sq.m of Use Class E and F.2 uses, a primary school (Use Class F.1), country park and other open space including sports pitches and associated facilities, access roads and landscaping with associated works including demolition, infrastructure, earthworks and drainage.

LOCATION: Proposed Residential And Commercial Development Land, Tasley, Bridgnorth, Shropshire, .

This is your opportunity to submit a comment to Shropshire Council either supporting or opposing the application. Not to object to the planning application is the same as supporting it.

The consultation ends on **Monday 14 July 2025**.
